NOTICE OF RACE

HOST: U S Sailing Center, Martin County

SITE: US SAILING Center, Martin County, 1955 Indian River Dr. NE, Jensen Beach, FL 34957

1. RULES

This regatta will be governed by the current ISSA and SAISA Procedural Rules, *The Racing Rules of Sailing*, the prescriptions of US SAILING, this Notice of Race, and the Sailing Instructions. Advertising will be restricted to Category A.

2. SCHEDULE OF RACES

Saturday, Sept 23:

0900 Arrival and check-in, boat rigging.
0930 Competitors' meeting
1000 Start of first race of the day

Sunday, Sept 24:

0900 Competitor's meeting
0945 Start of the first race / team race scrimmage
1400 No race to be started after this time

3. FORMAT

3.1 This will be a two-division regatta; teams will rotate through the boat per a rotation posted on the day of the event. A Sound Signal Starting System shall be used. Time permitting; the Race Committee will attempt to run a multiple series of races. Competitors should expect numerous short races with boat rotations as set forth at the skipper's meeting. It shall be the goal of the race committee to complete one full round robin rotation of boats. If racing is needed on Sunday, to complete a fair round robin rotation, schools should be prepared to race on Sunday. Three races in each division must be completed to constitute a regatta. All coaching, including instruction, assistance, equipment or sustenance shall be provided only on shore or on a designated vessel on the water.

4. SCORING

Low point system for individual races as modified by ISSA Rule 9. Ties will be resolved per procedural rule 11(c). Note that when the school "team" is composed of 2 or more sailors from different schools the composite team sailor's schools will be indicated on the results. Minimally the 1st -3rd divisional & top 3 places will indicate the names of the sailors on the race results. Race highlights with results will be forwarded to SAISA for processing & points will be awarded to qualify for participation in the District Championship & qualifier for the ISSA Mallory Trophy regatta.

5. AWARDS

Prizes may be awarded after completion of the last race with results to follow.

6. FEES

The entry fee shall be \$30.00 per each school team, paid in advance by using the [registration](#) and [waiver](#) forms available on the South Atlantic Interscholastic Sailing Assoc. website (www.saisa.org) listed under "General Forms - [Samples](#)". Check should be made payable to **USSCMC**; mail with Registration and Waiver Forms to; SP 1 Regatta, USSCMC, 1955 Indian River Drive, Jensen Beach, FL 34957.

7. ELIGIBILITY

7.1 All 2006-07 Member Schools of the South Atlantic Interscholastic Sailing Association (SAISA) are welcome. The regatta is a South Points Regatta. Points will be awarded to qualify for participation in the Mallory District Championship & Qualifier for ISSA fleet racing nationals, within the South Atlantic District.

7.2 All schools must be members in good standing with SAISA. If a school wishes to participate, and has not yet paid the ISSA/SAISA dues, they will be provided the opportunity to pay dues at check-in. *If a North Point school wishes to participate they may be required to provide their own 420. The NP school will be scored in place similar to a JV team.*

7.3 Registration is on a first paid/first allowed basis. Once 11 schools have registered, each school will be notified that their entry shall be contingent upon their ability to bring their own 420 sailboat to add to the rotation.

7.4 Competitors must attend the school they represent full time and must be in the 8th, 9th, 10th, 11th, or 12th grade, as of the date of the Regatta. If your school does not have sufficient sailors to form the necessary teams, we will attempt to "mix and match" sailors from different member schools.

7.5 An adult school representative/advisor is required to accompany each team and be responsible for their conduct on and off the water. The team representative, who may be an advisor, coach, or parent, is expected to have full authority to obtain medical treatment for his team members.

7.6 Eligible SAISA schools may enter both varsity and JV teams, however only the varsity team score will be used to determine South Points. A JV team from eligible schools may also be entered only when pre-approved by SAISA. For JV team approval, contact Tom Monkus at (727) 821.9080. Depending on boat availability, each JV team may be responsible for providing their own 420 (will not be rotated through the fleet), as preference will be given to high schools with only one team.

8. SAILING INSTRUCTIONS

Sailing Instructions will be available upon check-in.

9. BOATS

Collegiate 420's will be used, and 11 will be provided by the venue. Personal safety equipment including US Coast Guard Type III PFDs must be furnished by the competitors. Bailers will not be provided.

10. RACING AREA

Racing will be on the Indian River, south of the Jensen Beach Causeway.

11. LUNCHES

Plan to bring your own lunch. Bring water bottles. Cooler with ice available and water fountain to refill.

12. DAMAGE

Damage that requires more than normal maintenance is considered a serious incident. If the Regatta Chairman determines that reasonable care was not used and resulted in damage one or both boats may be disqualified regardless of any alternative penalties already taken. In extreme cases, either or both boats may be excluded from the rest of the regatta and held financially responsible for the damages.

13. DIRECTIONS

13.1 From 95:

Take exit 102 PALM CITY and follow the access road, High Meadow Road, north to Route 74 off the exit ramp. Continue north on High Meadow Road to the second set of lights, and turn right (east) on Martin Downs Road. Follow Martin Downs Road east and proceed over the Palm City Bridge. Martin Downs Road continues straight and becomes Route 714/SE Monterey Road. Bear left at the fork in the road about .9 of a mile past the intersection with Route 76/Kanner highway. Continue straight on Route 714/SE Monterey Road past Rt. 1 and Route A1A. Turn right when Route 714/SE Monterey Road dead ends at Route 1A/SE Ocean Blvd. Follow SE Ocean Blvd. east over the Cray Bridge. Turn Left at the next set of

lights onto Sewall's Point Road. Sewall's Point Road becomes Indian River Drive. About 2 miles after the set of lights you will pass Indian Riverside Park. USSCMC is the next right turn driveway about a 10th of a mile further down the road. If you pass the Texaco gas station on your left you have gone too far.

13.2 From the Florida Turnpike:

Take exit 133 Martin Downs and go Straight off the exit ramp on to Martin Downs Rd. Follow Martin Downs Road east and proceed over the Palm City Bridge. Martin Downs Road continues straight and becomes Route 714/SE Monterey Road. Bear left at the fork in the road about .9 of a mile past the intersection with Route 76/Kanner highway. Continue straight on Route 714/SE Monterey Road past Rt. 1 and Route A1A. Turn right when Route 714/SE Monterey Road dead ends at Route 1A/SE Ocean Blvd. Follow SE Ocean Blvd. east over the Crary Bridge. Turn Left at the next set of lights onto Sewall's Point Road. Sewall's Point Road becomes Indian River Drive. About 2 miles after the set of lights you will pass Indian Riverside Park. USSCMC is the next right turn driveway about a 10th of a mile further down the road. If you pass the Texaco gas station on your left you have gone too far.
